8. Supplier has to quote separately for new batteries and buy-back offer for old ones.
9. Warranty against manufacturing/ functional defects should be for a period of minimum **36 months** from the date of installation.
10. Test of batteries is to be carried out at IOP site for all parameters in presence of IOP Engineer-in-Charge.
11. Firms are requested to inspect (if required) the old batteries during any of Institute working days between 11.00 AM to 1.00 PM before quoting for the same.
12. Old batteries will be handed over to the successful bidder after installation of the new batteries at IOP site as on where is basis.
13. Buy –back offer price quoted by the bidder for old batteries will be deducted from the total cost for new batteries and accordingly payment will be made as per the payment terms and conditions.
14. Security deposit of 10% of the total purchase order value will be deducted from the final bill payment and will be kept with us till the completion of the warranty period or else the supplier has to submit a bank guarantee of equivalent amount to 10% of the final bill valid for the warranty period for 100% payment.
