**Subject:-** Submission of Immovable Property Returns (IPRs) by officers of Group 'A' Central Services for each year and placing the same in public domain.

Reference is invited to DoPT O.M. No.11013/3/2001-Estt.A-IV dated 11.04.2011 (endorsed vide DAE.Note No.1/3(2)/20011-Vig./5711 dated 26.06.2011) requesting the Cadre Controlling authorities to place the Immovable Property Returns of Group 'A' Officers for the year 2010, latest by 31.05.2011 in the public domain (Annex-I).

2. Subsequently, vide OM No F No 11013/3/2011-Estt (A) dated 23.09.2013 (Annex II) DoPT clarified that placing of IPRs in the public domain was not a one time measure but would be a continuous process and inter-alia requested that the IPRs (to be submitted by 31st January every year) may be placed in the public domain by 31st March of that year.

3. As the Department is required to furnish a compliance report in this regard to DoPT by 30th April every year, it is requested that the Immovable Property Returns submitted by Group 'A' officers of the respective Unit may be placed on respective websites, within the stipulated time and a compliance report in this regard may be furnished to the Department latest by 15th March every year. The information relating to the year 2013 may accordingly be submitted to the Department latest by 15.03.2014.

Conduct Rules for Railways and other Rules in respect of Central Government servants contain similar provisions.

2. It has been decided that the immovable property returns submitted by members of all Group 'A' Services of the Central Government for the year 2010 i.e. as on 01.01.2011 will be placed in public domain by the respective cadre controlling authorities by 31.05.2011. A copy of the circular in this connection issued by Establishment Officer to all Ministries/Departments is also enclosed herewith.

3. All the Cadre Controlling authorities in respect of Group 'A' Central Services are requested to ensure compliance. They are also requested to report status on 31.05.2011.

Subject:- Submission of Immovable Property Returns by IAS officers for the year 2010 (as on 1.1.2011) – Placing on the public domain regarding.

Sir,

As per Rule 16(2) of AIS (Conduct) Rules, 1968, all the members of the Service are required to submit their Immovable Property Returns (IPRs) latest by 31<sup>st</sup> January every year. Vide this Department's circular of even number, dated 22<sup>nd</sup> December, 2010, all State Governments and Central Ministries/Department were requested to forward Immovable Property Returns of all IAS officers for the year 2010, to the Department of Personnel and Training (DOPT) latest by 15<sup>th</sup> February, 2011. Subsequently D.O. letter were issued to all Chief Secretaries by Secretary, DOPT to forward the IPRs of all IAS officers borne on their cadre latest by 26<sup>th</sup> March, 2011.

2. It has been decided that officers who do not submit the property return in time would be denied Vigilance Clearance and will not be considered for promotion and empanelment for senior level posts in Government of India. Government of India have also decided that the annual property return as on January 1, 2011 of members of All India Service and other Group 'A' Central Service Officers will be placed in the public domain.

3. Against this backdrop, it is once again requested that IPRs all IAS officers working in the State Governments and Central Ministries/Dept. be forwarded to reach us positively by 5 P.M. on 20.4.2011.


