- 3) The tender must be submitted in a sealed cover superscribed "offer for sale of condemned vehicle". The last date for submission of tender is 3.00 P.M. of dt.22.11.2010. The tender will be opened on the same day at 4.00 P.M. in the Conference Hall of the Library of the Institute.
- 4) The tender must be accompanied by an earnest money deposit of Rs.5,000/= (Rupees Five Thousand) only in form of a demand draft drawn in favour "Director, Institute of Physics, Bhubaneswar-751005". Offers not accompanied by E.M.D. will be liable for rejection.
- 5) The amount deposited by the successful tenderer as E.M.D. will be adjusted against the bid value subject to final acceptance of his offer by "Director, Institute of Physics, Bhubaneswar" who reserves the right of accepting or rejecting any/all offers without assigning any reason.
