The gas shall be supplied compressed in cylinders The design of the cylinders, pressure of gas in the cylinders, packing, marking, painting, labelling and transport of cylinders shall be in accordance with the Gas Cylinder Rules, 1940, with such modifications as may be ordered from time to time by the Chief Inspector of Explosives, Government of India or other duly constituted authority".
5. Damage to Cylinder and parts there of- The price accepted include the prices of the damages to valves/cylinders in the prices of gases as responsibility of enroute damages and supplying of the gas in sound cylinders as per Gas Cylinder Rules,1981 would rest with seller in the absence of any inspection of the same, They will also take care of the proper loading/unloading of the cylinders and briefing /training of consignees in the handling of cylinders"

8. Rate quoted should remain valid for one year from the date of opening of the quotation and may be extended/renewed further on the basis of performance during the service period. The order quantity may be increased or decreased.
9. Price quoted should be FOR destination at IOP site basis. The quote price should be included all charges to deliver at IOP site except GST which should be specified separately.
